ITB 6	Bid submission form
	The bidder shall submit the bid submission form using the form furnished in this document. This form must be completed without any alteration to its format and all blank spaces shall be filled in with the information requested.
ITB 7	Bid price
	Prices indicated in the form of bid shall include all levies and taxes payable by the bidder. However VAT and other taxes shall not be included in the price but shall be indicated separately.
ITB 8	Format and signing of bids
ITB 8.1	The original bid shall be signed by a person duly authorized to sign on behalf of the owner.

9.3	Duly completed bid shall be delivered and deposited in the tender box available at the Administration Division of National Education Commission or sent by Registered Post to the following address to reach on or before 2.00 p.m. on 25/08/2021.



15 Personal seated board room need multimedia conference system. This system must suit to MS Teams, Zoom and common teleconference software. Proper internet connection is provided to the room.

Major requirements are,

- From the Place labeled "A" camera need to be fixed. Camera "A" Specifications attached. (Spec 01)
- Chairpersons table top central controlled "Goose neck" microphone. Specifications attached. (Spec 02)
- 12 table top microphones "Goose neck" that each microphone will support two persons to talk. Specifications attached. (Spec 03)
- One Omnidirectional microphone should be available other than goose neck microphones.
- All the microphones and camera must connect to the laptop which operates online meeting such as "Zoom".
- From the Place labeled "B" is the place to locate the operators laptop Specifications attached. (Spec 04)
- The location "C" placed camera Specifications attached. (Spec 01) is focus to the majority of participants. It should be placed at the celling next to existing multimedia projector.
- All the equipment's (cameras and microphones) need to be connected to the operator's laptop through proper multimedia connectivity devices (Audio / Video mixture device). Those devices must be compatible to Ms-Teams and Zoom.

- From above Central controller laptop connected 59 inches monitor need to be fixed for chairperson's view.
- Proper cable system needs to be established.
- Cable connection to be connected to the existing sound system is needed.
- Alternative PC connected proper speaker for the room needed.

All the interested bidders are welcome to supervise the operation room at a given appointment.
